Bidvest Bank & Mastercard to offer international remittance



Inflation, high interest rates erode average takehome pay

#### service for South Africans

Mastercard has partnered with Bidvest Bank to launch Bidvest Bank BidSend, a solution enabling customers to send international remittances conveniently. This real-time payment network, powered by Mastercard cross-border services, allows users to send money to 103 countries, and allows senders to select their beneficiary's preferred choice of pay-outs as cash, onto a mobile wallet or as bank account payments.

The BankservAfrica Take-home Pay Index, which tracks the average nominal take-home pay among four million salary earners in South Africa, has painted a bleak picture for 2023. While the average nominal take-home pay was 5.6 per cent higher in December 2023 compared to December 2022, rising inflation over this period means salary earners were worse off.
